- 1. Qualifications of the Firm and Key Personnel
- 2. Demonstrated understanding of airport needs.
- 3. Experience in representing airports with similar requirements.
- 4. Experience with State and Federal Grant Programs and Requirements with the Chicago ADO
- 5. Ability to provide responsive service to the airport.

The successful respondent firm will be selected based on desired qualifications as outlined herein. Fee information will not be considered during the selection process. The resulting agreement shall be utilized on an as-needed or as-required basis. Therefore, the Airport does not guarantee an agreement value of any amount for services rendered under this proposed contract.

A detailed copy of the most recent CIP, ALP, or Master Plan can be requested from the Airport. Consultants should be familiar with Federal Aviation and State Aviation funding programs and requirements.

The top firm will be invited to negotiate a contract with the Terre Regional Airport. If a successful negotiation cannot be reached, the Terre Haute Regional Airport reserves the right to negotiate with the next qualified firm.
